ORDINANCE NO. 10893

AN ORDINANCE RELATING TO COMPENSATION FOR CITY ELECTED OFFICIALS AND AMENDING SECTIONS 3.12.010 AND 3.12.020 OF THE BELLINGHAM MUNICIPAL CODE

WHEREAS, the compensation package for city council members was last increased in 1991; and

WHEREAS, the time spent by city council members on official business has increased since 1991; and

WHEREAS, Section 2.09 of the City Charter provides that the Mayor's salary should at no time be less than that of the highest paid City official or employee; and

WHEREAS, a survey of salaries for comparable officials in similarly sized cities in Washington has demonstrated that Bellingham's salary for Mayor is substantially under the average for those cities; and

WHEREAS, an increase in the salary for the Finance Director is necessary to maintain internal equity among department heads; and

WHEREAS, maintenance of an adequate level of compensation for elected officials is important to retaining and recruiting of qualified candidates;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. Bellingham Municipal Code Section 3.12.010 A. is amended to read as follows:

3.12.010 -- Council Members

- A. Effective January 1, 1992 1998, the annual salary for members of the City Council shall be in accordance with the following schedule:
 - (1) January 1, 1992 1994, \$900.00 per month;
 - (2) January 1, 1994 1998, \$1000.00 \$1250.00 per month; thereafter, such salary shall increase annually by 3%, beginning January 1, 1999.

provided, however, pursuant to Article 11 of the Washington State Constitution, such salary increase shall not apply to council members during their current term of office or as otherwise prohibited by the state constitution.

B. -- C. (remain unchanged)

Section 2. Bellingham Municipal Code section 3.12.020A shall be amended to read as follows:

3.12.020 -- Mayor and Finance Director

- A. The basic salary attaching to the positions of Mayor and Finance Director <u>beginning in for 1989</u>

 1998, subject to the cost-of-living increase allowed for other exempt employees in 1998, is as follows:
- (1) Mayor: Fifty thousand, six hundred and four dollars per year 5% above the highest salary level of department head positions;
 - (2) Finance Director: Forty-one thousand, four hundred twenty-four 5826 dollars per yearmonth.

Thereafter, such salaries shall be increased annually by the same percentage amount as salaries are increased for exempt employees, unless the Council directs otherwise by budget or other ordinance.
