

ORDINANCE NO. 1998-03-012

AN ORDINANCE RELATING TO THE 1998 BUDGET AND APPROPRIATING \$9,340.00 IN ADDITIONAL RESOURCES IN THE GENERAL FUND FOR THE PURPOSE OF FUNDING THE REPLACEMENT OF THE SYRE EDUCATION CENTER'S ROOF TOP COMPRESSOR AND PROVIDING FOR A MAINTENANCE CONTRACT ON THE NEW COMPRESSOR, FROM ESTIMATED ENDING UNRESERVED BALANCE.

WHEREAS, after the adoption of the 1998 budget the roof top compressor on the Syre Education Center failed; and

WHEREAS, it is critical to the preservation of the photo documents that are stored in the building to maintain a specifically controlled environment; and

WHEREAS, it is advisable to place the new compressor under a maintenance contract to assure that it is properly maintained;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. The sum of \$9,340.00 is hereby appropriated in the General Fund for the purpose of funding the replacement of the Syre Education Center's roof top compressor and providing for a maintenance contract on it. The source of funding will be from:
