

ORDINANCE NO. 1998-04-021

AN ORDINANCE RELATING TO THE 1998 BUDGET AND APPROPRIATING \$6,056.00 IN ADDITIONAL FUNDS IN THE MUSEUM DEPARTMENT OF THE GENERAL FUND FOR THE PURPOSE OF REPLACING THE HEAT EXCHANGER WHICH WAS FOUND TO BE FAULTY DURING THE REPLACEMENT OF THE COMPRESSOR, FROM ESTIMATED ENDING UNRESERVED BALANCE.

WHEREAS, Bellingham Municipal Code section 4.80.010(E)(5) authorizes the City to dispense with formal bid processes when an emergency requires the immediate purchase of equipment; and

WHEREAS, during a project to replace the compressor on the chiller at the Syre Addition to the Museum the contractor found that the heat exchanger was leaking and had to be replaced; and

WHEREAS, failure to replace the heat exchanger immediately would allow water to continue to enter the refrigerant system and cause additional damage; and

WHEREAS, the contractor was able to obtain a quote from a reputable vendor who could promptly deliver the new equipment and do so at a competitive price, and the contractor was therefore authorized to place the appropriate order;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

The sum of \$6,056.00 is hereby appropriated in the General Fund for the purpose of providing the needed funding to replace the heat exchanger using the current contract with Blythe Plumbing and Heating, as amended, as authorization for the work. The details of the added purchase are set forth on attached Exhibit "A" which is incorporated by this reference. The source of funding will be from:
