

ORDINANCE NO. 1998-07-045

THE SUM OF \$42,809.00 IS HEREBY APPROPRIATED IN THE GENERAL FUND FOR THE PURPOSE OF CREATING AN INTERGOVERNMENTAL RELATIONS POSITION, FROM ESTIMATED ENDING UNRESERVED BALANCE.

WHEREAS, the legislative needs of the City can be best met by creating an intergovernmental relations position;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

The sum of \$42,809.00 is hereby appropriated in the General Fund Legal Department for the purpose of providing additional compensation to an Attorney 2 position and the necessary support costs for the remainder of 1998 to work in the intergovernmental relations area and also add one additional Attorney 2 position.
