ORDINANCE NO. <u>1998-07-060</u>

AN ORDINANCE RELATING TO THE 1998 BUDGET AND AMENDING THE TERMS OF THE INTERFUND LOAN TO BE MADE BETWEEN THE SEWER FUND AND THE CUMULATIVE WATER TRANSMISSION AND RESERVOIR FUND AND REMOVING ONE MONTH OF REPAYMENT IN 1998.

WHEREAS, the 1998 Budget as adopted by Ordinance 10918 authorized an interfund loan of \$851,800.00 from the Sewer Fund to the Cumulative Water Transmission and Reservoir Fund for water system improvements to the Cordata pumping zone area; and

WHEREAS, between the time the budget was adopted and now market interest rates have decreased and it is appropriate to change the terms of the loan to reflect the change;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. The terms of the interfund loan authorized by the 1998 budget and adopted by ordinance 10918 will be changed as follows:

A. The interest rate will be reduced from 6.5% to 6.0%.

B. The loan will be made on July 31, 1998 rather than June 30, 1998.

C. The five (5) year repayment plan will start August 31, 1998 rather than July 31, 1998.

Section 2. As a result of the change in terms the impact on the budget will be as follows:

A. The sum of \$17,660.60 is hereby reduced in the Cumulative Water Transmission and Reservoir Fund to reflect the lower interest rate and having one month less of repayment in 1998. The source of funding will be from:
