WHEREAS, the Technical Review Committee has considered the petition of the Bellingham School District for

the vacation of portion of Ellis Street and Iowa Street, and

WHEREAS, the Bellingham School District is a public entity and provides a major public service by educating

the children of the City of Bellingham, and

WHEREAS, easements will preserve needed utility, pedestrian, and bicycle access, and

WHEREAS, the Bellingham School District will provide improvements to public rights of way to make

restitution for loss of access to private properties, and

WHEREAS, all the jurisdictional steps preliminary to the vacation have been taken as provided by law, NOW

THEREFORE,

THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. That portion of Ellis Street immediately north of the north line of Ohio Street and South of the

south line of Kentucky Street; and a portion of Iowa Street east of the east line of Ellis Street and west of the

west line of the Ellis/Franklin Alley as shown in Exhibit A is hereby vacated.

Section 2. That a full-width public and private easement be maintained along Ellis Street from the south

line of Kentucky Street to the north line of Ohio Street and along Iowa Street from the east line of Ellis Street to

the west line of the Franklin/Ellis alley.

Section 3. That a bicycle/pedestrian easement to be established and maintained from the Kentucky/Ellis

intersection to the Ohio/Ellis intersection. The exact location with width of this easement and the trail

construction standards shall be determined by the Parks and Recreation Department and the Public Works

Department.

Section 4. That the Bellingham School District shall make the following street improvements (or

sufficient financial security shall be provided) as per the review and approval of the Public Works Department:

- A. Pave the northwest corner of Iowa and Franklin Street to accommodate large truck traffic, as reviewed and approved by the Public Works Department.
- B. Provide a single paved access driveway onto Kentucky Street from the lot west of Franklin Street, as reviewed and approved by the Public Works Department.
- C. If determined by the Public Works Department after the new Bellingham High School opens, install stop signs to Kentucky Street at Franklin.
- D. Post no-parking signs on the west side of Franklin Street between Kentucky and Iowa Streets, as approved by the City Council.
- Section 5. That the following lots shall be bound by covenant; all of the lots in the west halves of Block 274 and 255, Town of New Whatcom which are west of the Chicago, Milwaukee, St. Paul and Pacific Railroad.
- Section 6. That due to the extreme value to the general public of the renovation of Bellingham High School and its grounds and that this vacation is being undertaken by a public agency for public purposes, the City of Bellingham will not charge for the value of this right of way to be vacated.
- Section 7. That no damage will result to any person or persons or to any property by reason of the vacation of said property.


