

ORDINANCE NO. 1998-08-069

AN ORDINANCE RELATING TO THE 1998 BUDGET AND APPROPRIATING \$249,703.00 IN THE GENERAL FUND POLICE DEPARTMENT FOR THE ACCEPTANCE OF A DEPARTMENT OF JUSTICE GRANT TO BE USED FOR COMMUNITY POLICING EFFORTS, FROM UNANTICIPATED REVENUE.

WHEREAS, approval has been received in June of 1998 from the Federal Government for a Department of Justice Grant to be used for community policing efforts; and

WHEREAS, this grant was not included in the 1998 budget and now needs to be added to the Police Department appropriation authority;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:
