ORDINANCE NO. 1999-05-031

AN ORDINANCE RELATING TO THE 1999 BUDGET AND APPROPRIATING \$120,824.58 IN ADDITIONAL RESOURCES IN THE GENERAL AND STREET FUNDS FOR THE PURPOSE OF COVERING A HIGHER THAN ANTICIPATED COST FOR THE PAYMENT TO WHATCOM COUNTY PURSUANT TO THE BAKERVIEW SPUR ANNEXATION AGREEMENT AND ALSO TO COVER THE HIGHER THAN EXPECTED COST OF THE ANNUAL DRAINAGE ASSESSMENTS, FROM UNANTICIPATED REVENUE AND ENDING UNRESERVED BALANCE.

WHEREAS, the annexation agreement between the City of Bellingham and Whatcom County for the Bakerview Spur Annexation called for the City to share with the County a portion of the sales tax revenue gained by the City and lost by the County; and

WHEREAS, at the time of the adoption of the 1999 budget the amount to be paid had not been determined and the City's budget estimate was lower than the amount that was finally determined; and

WHEREAS, when the 1999 budget was adopted the City was not aware that the drainage assessment collected with the annual property taxes would be doubled from what it was in 1998:

NOW. THEREFORE. THE CITY OF BELLINGHAM DOES ORDAIN:
