ORDINANCE NO. <u>1999-07-045</u>

AN ORDINANCE RELATING TO THE 1999 BUDGET AND APPROPRIATING \$220,221.19 IN ADDITIONAL FUNDS IN THE GENERAL AND CRIMINAL JUSTICE FUNDS FOR THE PURPOSE OF CLOSING OUT THE CRIMINAL JUSTICE FUNCTION IN THE GENERAL FUND AND MOVING IT TO THE CRIMINAL JUSTICE FUND, FROM ESTIMATED ENDING RESERVED BALANCE.

WHEREAS, at the time of adoption of the 1999 budget it was anticipated that the State Criminal Justice Funds remaining in the General Fund would have been transferred to the new Criminal Justice Fund and would have not been in the General Fund as of January 1 and would have been shown as beginning reserve balance in the Criminal Justice Fund; and

WHEREAS, the transfer did not happen as anticipated and the resources are still in the General Fund and need to be transferred to the Criminal Justice Fund; and

WHEREAS, the first of year reconciliation ordinance has already adjusted the Criminal Justice Fund to show that the resources were not in the Fund as expected;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. The sum of \$220,221.19 is hereby appropriated in the General Fund for the purpose of moving the remaining State Criminal Justice Funds to the Criminal Justice Fund. The source of funds will be from:
