AN ORDINANCE RELATING TO THE 1999 BUDGET AND APPROPRIATING \$12,513,031.82 IN ADDITIONAL FUNDS IN VARIOUS FUNDS TO RECOGNIZE THE DIFFERENCES BETWEEN ESTIMATED BEGINNING RESERVE BALANCES AND ACTUAL 1999 BEGINNING RESERVE BALANCES AND PLACING THOSE DIFFERENCES IN THE ENDING RESERVE BALANCES.

WHEREAS, when preparing the annual budget it is not possible to estimate the exact amounts of beginning reserve balance to be available for the coming year; and

WHEREAS, pursuant to council approved finance policy 96-2 the differences between estimated and actual beginning reserve balances are to be recognized by ordinance and the differences placed in estimated ending reserve balance accounts; and

WHEREAS, the amounts for 1999 are available and are included in this ordinance;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

The sum of \$12,513,031.82 is hereby appropriated in various funds to recognize the difference between estimated and actual beginning reserve balances and placing the differences in ending reserve balance accounts. The source of funding will be from:
