## **ORDINANCE NO.** 1999-09-059

AN ORDINANCE RELATING TO THE 1999 BUDGET AND APPROPRIATING \$600,000.00 IN ADDITIONAL FUNDS IN THE LID GUARANTY, GENERAL AND GENERAL RESERVE FUNDS FOR THE PURPOSE OF REALLOCATING EXCESS RESERVE FUNDS FROM THE LID GUARANTY FUND TO THE GENERAL AND GENERAL RESERVE FUNDS, FROM ESTIMATED ENDING DEBT RESERVE BALANCE AND UNANTICIPATED REVENUE.

WHEREAS, the balance in the LID Guaranty Fund exceeds the 12% ratio that is recommended; and

WHEREAS, no new large LID's are anticipated for at least two years; and

WHEREAS, our reserve balances in other funds are not at our goal levels;

Section 1. The sum of \$600,000.00 is hereby appropriated in the LID Guaranty Fund for the purpose of reducing the funding level down to the recommended 12% level. The source of funding will be from:
