## ORDINANCE NO. 2000-03-005

AN ORDINANCE RELATING TO THE VACATION OF 15' WIDE RACINE STREET RIGHT-OF-WAY ABUTTING LOT B, WOOD SHORT PLAT, LOT 2, SUNSET GARDENS SHORT PLAT AND LOT LINE ADJUSTMENT IN BELLINGHAM (EXHIBIT A). GENERALLY LOCATED BETWEEN EAST SUNSET DRIVE AND THE SOUTHERN BOUNDARY LINE OF CLOVER LANE ALL SITUATED WITHIN THE CITY OF BELLINGHAM; FINDING AND ADJUDGING THAT NO DAMAGE ACCRUE TO ANY PERSON OR PROPERTY BY REASON THEREOF, AND UTILITIES MOVED SHALL BE MOVED AT THE EXPENSE OF THE PETITIONER.

## THE CITY OF BELLINGHAM DOES ORDAIN:

**Section 1.** That the 15' wide Racine Street right-of-way abutting Lot B, Wood Short Plat and Lot 2, Sunset Gardens Short Plat and Lot Line Adjustment generally located between East Sunset Drive and the southern boundary line of Clover Lane in Bellingham is hereby vacated upon completion of the property dedication described in Section 3.

**Section 2.** That said vacation is subject to reservation of rights to the City of Bellingham for utility, access and trail easements within the right-of-way. Any utility to be moved shall be moved at the expense of the petitioner.

**Section 3.** That the Petitioner has dedicated real property described in EXHIBIT B fee simple to the City of Bellingham in exchange for the subject 15' wide Racine Street right-of-way.

**Section 4.** That no damage will result to any person or persons or to any property by reason of the vacation of said property.




