

ORDINANCE NO. 2000-06-030

AN ORDINANCE RELATING TO THE 2000 BUDGET AND APPROPRIATING \$73,429.00 IN ADDITIONAL RESOURCES IN THE GENERAL FUND FOR THE PURPOSE OF FUNDING THE OFFICE OF HEARING EXAMINER, FROM UNANTICIPATED I-695 REVENUES.

WHEREAS, the City has recently adopted an ordinance creating the Office of Hearing Examiner; and

WHEREAS, it is necessary to provide funds for the operation of the newly created office; and

WHEREAS, it is unknown as to how much revenue the position will generate so the funding for 2000 will come from non-recurring I-695 revenues;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

The sum of \$73,429.00 is hereby appropriated in the General Fund for the purpose of funding the newly created Office of Hearing Examiner. The source of funding will be from:
