

AN ORDINANCE RELATING TO THE 2000 BUDGET AND APPROPRIATING \$21,100.00 IN ADDITIONAL FUNDS IN THE GENERAL FUND FOR THE PURPOSE OF RECOGNIZING TWO TOURISM GRANTS AND PRIVATE DONATIONS FOR THE BIG ROCK PARK SCULPTURE GARDEN, FROM UNANTICIPATED INTERFUND REVENUE AND PRIVATE GRANTS.
