

ORDINANCE NO. 2000-07-041

AN ORDINANCE RELATING TO THE 2000 BUDGET AND APPROPRIATING \$33,000.00 IN ADDITIONAL FUNDS IN THE CEMETERY IMPROVEMENT AND CEMETERY FUNDS FOR THE PURPOSE OF CREATING A NEW CREMATION GARDEN MEMORIAL SECTION, FROM ENDING RESERVE BALANCE AND AN UNANTICIPATED OPERATING TRANSFER.

**WHEREAS**, the Cemetery Master Plan recommends a new cremation garden as part of the Mother's Memorial section; and

**WHEREAS**, the Mothers group is prepared to have their sculpture placed in the garden; and

**WHEREAS**, it is an appropriate time to develop the new cremation garden from funds existing in the Cemetery Improvement Fund;

**NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:**

**Section 1.** The sum of \$33,000.00 is hereby appropriated in the Cemetery Improvement Fund for the purpose of transferring money to the Cemetery Fund for the development of a cremation garden. The source of funds will be from:




