AN ORDINANCE RELATING TO THE 2000 BUDGET AND APPROPRIATING \$318,000.00 IN ADDITIONAL RESOURCES IN THE WATER AND WASTEWATER FUNDS TO PROVIDE FOR THE INSTALLATION OF FIBER OPTIC CABLE TO IMPROVE THE PERFORMANCE OF THE CITY'S SUPERVISORY CONTROL AND DATA ACQUISITION (SCADA) SYSTEM, FROM CHARGES TO OTHER GOVERNMENTAL AGENCIES AND ENDING RESERVE BALANCES.
