## ORDINANCE NO. 2000-10-064

AN ORDINANCE RELATING TO THE 2000 BUDGET AND APPROPRIATING \$138,863.32 IN ADDITIONAL FUNDS TO CLOSE THE POLICE FACILITY REMODEL AND EXPANSION FUND AND MOVING THE REMAINING DOLLARS TO THE GENERAL FUND AND RESERVING THEM FOR FUTURE CONSTRUCTION PURPOSES, FROM ENDING RESERVE BALANCE AND AN UNANTICIPATED TRANSFER.

**WHEREAS,** the Police Facility Remodel and Expansion Fund was created by ordinance 10006 for the purpose of accumulating funds and accounting for the construction of the current Bellingham Police Facility; and

**WHEREAS**, the funds remaining after the construction was completed were retained for future Police facility needs; and

WHEREAS, additional funding has not been accumulated to allow for the future facility construction project; and

WHEREAS, changes in accounting requirements make it beneficial to close the Police Facility Remodel and Expansion Fund and move the money to the General Fund where it can be reserved for future use; and

WHEREAS, when sufficient other funding becomes available the reserved resources can be transferred into a new construction fund along with other resources to account for the future construction;

## NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

**Section 1.** The sum of \$136,719.32 is hereby appropriated in the Police Facility Remodel and Expansion Fund to provide for the close out of the fund and movement of the remaining cash balance to the General Fund. The source of funding will be from:
