NOW THEREFORE,

THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. That the western ½ (40') of 15th Street abutting Lot 20, Block 125,

Fairhaven Land Company's 2nd Add to Fairhaven excluding that portion of State Highway Route 11 right-of-way. Generally located between Interstate 5 and Lake Padden

(EXHIBIT B) in Bellingham is hereby vacated.

Section 2. Full width easements shall be retained by the City of Bellingham for all

utilities, stormwater facilities, public access and landscaping.

Section 3. Any utility to be moved shall be moved at the expense of the petitioner.

No damage will result to any person or persons or to any property by reason of the vacation of said property.

Section 4. That the Petitioner has deposited \$6,200.00 into the Street Storm Sewer

Capital Improvement Fund for the City of Bellingham and a landscape easement for the northern 10' of the applicants parcel (Lots 19 and 20, Block 125, Fairhaven Land

Company's 2nd Add to Fairhaven) has been recorded with the Whatcom County Auditor.
