ORDINANCE NO. 2002-12-092

AN ORDINANCE AMENDING CHAPTER 17.16.060 OF THE BELLINGHAM MUNICIPAL CODE, REVISING TABLE 1A, SECTION 404.2 OF THE ADMINISTRATIVE CODE PROVISIONS OF THE 1999 EDITION OF THE NATIONAL ELECTRICAL CODE, REGARDING ELECTRICAL PERMIT FEES.

WHEREAS, Chapter 17.16 of the Bellingham Municipal Code was adopted by the City as part of the Administrative Code Provisions of the 1999 Edition of the National Electrical Code by Ordinance 1999-09-056; and,

WHEREAS, Municipal Code Section 17.16.060 amends the Section 404.2 of the Administrative Code Provisions of the 1999 Edition of the National Electrical Code, NEC Table 1A and prescribes fees for electrical permits; and,

WHEREAS, electrical permit fees as set forth in BMC 17.16.060 have remained unchanged since 1989; and,

WHEREAS, the Building Services Division of the Bellingham Fire Department commissioned a cost of services study to determine actual costs incurred by the City with regard to issuing electrical permits; and,

WHEREAS, the cost of services study indicates that the current electrical permit fee schedule produces revenues that only recover approximately 50% of the total costs incurred in the review, processing, and inspections necessary for the issuance of electrical permits; and,

WHEREAS, City Council has approved the cost recovery targets established by the Fire Department for electrical permit fees,

NOW, THEREFORE THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. Section 17.16.060 of the Bellingham Municipal Code is hereby amended as follows:

17.16.060 - Administrative Code Provisions, Section 404 Amended - Electrical Permit Fees

Section 404.2 of the Administrative Code Provisions to the National Electrical Code is amended and supplemented to establish electrical permit fees as follows:

- 8. Plan Review Fee. When plan review is required by 17.16.050, or when submittal documents are incomplete or changed so as to require additional plan review or when the project involves deferred submittal items, a plan review fee shall be charged at the rate of \$50 plus 35% of the permit fee.
- 9. Inspection and Reinspection Fees.

a. Inspections on a single project in excess of the maximum number required on the permit	\$ 75.00
b. Owner or contractor requested inspections on existing installations	\$ 50.00
c. Reinspection due to work not being ready or not access provided	\$ 50.00
d. Reinspection of same work more than two times	\$ 75.00

f. Installation or work covered or concealed before inspection	\$ 75.00
g. Partial inspection	\$ 50.00
