ORDINANCE NO. 2016-08-026

AN ORDINANCE RELATING TO THE COUNCIL WARDS OF THE CITY, PROVIDING FOR THE REDISTRICTING OF SUCH WARDS, AND AMENDING BELLINGHAM MUNICIPAL CODE CHAPTER 1.16 WHICH DESCRIBES EACH WARD BY ELECTION PRECINCTS

WHEREAS, the Bellingham City Charter, article 1, section 5, requires the wards of the City to be redrawn every four years if the number of registered voters in any one ward exceeds the number of registered voters in any other ward by more than fifteen (15) percent; and

WHEREAS, the City most recently amended the ward boundaries in April 2008; and

WHEREAS, staff members conducted an analysis in 2012 and determined that no amendments to the ward boundaries were needed at that time; and

WHEREAS, the maximum deviation in the number of registered voters between wards in City currently exceeds fifteen (15) percent; and

WHEREAS, RCW 29A.76.010 requires the City to periodically redistrict its governmental unit based on population information from the most recent federal decennial census; and

WHEREAS, the City has not redistricted its boundaries since receiving the most recent federal decennial census; and

WHEREAS, the maximum deviation in total population between wards should not exceed ten (10) percent to ensure equal representation throughout the City; and

WHEREAS, the maximum deviation in total population between wards currently exceeds ten (10) percent; and

WHEREAS, RCW 29A.76.010(5) requires the City to hold at least one public hearing on the redistricting plan prior to its adoption; and

WHEREAS, the City held the required public hearing on the proposed redistricting plan on July 25, 2016; and

NOW THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Sec 1, BMC 1,16,020 is amended to read as follows:

The first ward shall include all of that part of the city of Bellingham within the boundaries depicted upon the map which is attached to the ordinance codified in this chapter as Exhibit A. The boundaries of the six wards shall be defined in terms of precincts as described in this chapter and depicted on a map approved by the City Council. A copy of the map entitled "City of Bellingham Ward Boundaries Map 2016" shall be published on the City's web-site.

The precincts of the first ward are as follows: 201, 202, 203, 204, 205, and 206, 201, 202, 203, 204, 205, 206, 207, 209, 210, 222, and 268. The description of the boundaries of these precincts are as set forth in the amended and updated files of the Whatcom County election department.

Sec. 3. BMC 1.16.050 is amended to read as follows:

The precincts of the second ward are as follows: 208, 209, 210, 211, 212, and 214 208, 211, 212, 213, 214, 215, 217, 218, 219, 220, and 269. The description of the boundaries of these precincts are as set forth in the amended and updated files of the Whatcom County election department.

Sec. 4. BMC 1.16.070 is amended to read as follows:

The precincts of the third ward are as follows: 207, 213, 215, 216, 217, 218, 219, 220, 222, and 231 216, 223, 224, 225, 226, 227, 228, 230, 231, and 232. The description of the boundaries of these precincts are as set forth in the amended and updated files of the Whatcom County election department.

Sec. 5. BMC 1.16.090 is amended to read as follows:

The precincts of the fourth ward are as follows: 223, 224, 225, 226, 227, 228, and 229 221, 229, 233, 234, 235, 237, 238, 239, 240, 241, 242, and 243. The description of the boundaries of these precincts are as set forth in the amended and updated files of the Whatcom County election department.

Sec. 6. BMC 1.16.110 is amended to read as follows:

The precincts of the fifth ward are as follows: 221, 230, 232, 233, 234, 235, 236, 237, 238, and 239 244, 245, 246, 247, 248, 249, 250, 252, and 253. The description of the boundaries of these precincts are as set forth in the amended and updated files of the Whatcom County election department.

Sec. 7. BMC 1.16.130 is amended to read as follows:

The precincts of the sixth ward are as follows: 240, 241, 242, 243, 244, 245, 246, and 247 251, 254, 255, 256, 257, 258, 259, 260, 261, 262, 263, 264, 265, and 266. The description of the boundaries of these precincts are as set forth in the amended and updated files of the Whatcom County election department.
