ORDINANCE NO. 2016-11-039

AN ORDINANCE OF THE CITY OF BELLINGHAM, WASHINGTON AMENDING VARIOUS SECTIONS OF THE BELLINGHAM MUNICIPAL CODE IN ORDER TO ADOPT BY REFERENCE SEVERAL CRIMINAL CODES OF THE REVISED CODE OF WASHINGTON.

WHEREAS, the City of Bellingham prosecutes, under its own laws and within its own municipal court, all misdemeanor and gross misdemeanor offenses occurring within the City of Bellingham; and

WHEREAS, in order to prosecute state laws found in the Revised Code of Washington ("RCW"), the City must first adopt the specific state code by reference into the City's municipal code; and

WHEREAS, to protect the public health, safety, and welfare, the City desires to be current and up to date in its criminal code; and

WHEREAS, several offenses have been added to the RCWs in recent years which the City desires to enforce in its municipal court;

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:
