

## ORDINANCE NO. 2023-08-023

### AN ORDINANCE AMENDING THE 2023-2024 BIENNIAL BUDGET – AMENDMENT NO. 7





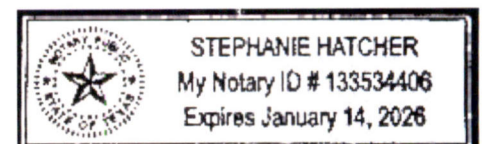
